Delivery to a location not at ground level or at a long distance from our truck must be arranged with us in advance for proper delivery. JUMBO PARTY RENTALS representatives will setup equipment in the safest place possible for your concern and for the concern of our equipment. **NO EQUIPMENT IS TO BE TAKEN APART OR MOVED TO ANOTHER LOCATION UNLESS JUMBO PARTY RENTALS GIVES LESSEE SPECIFIC PERMISION TO DO SO. <u>Lessee grants Lessor the right to enter location for delivery and pick up of equipment.</u> Any remaining payment must be made at time of delivery plus any delivery charge applicable to the area delivered to. Please make sure that arrangements for delivery and pickup service are explicit as there are extra charges if no one is home at time of delivery. Person signing contract and accepting full responsibility for its safe use must be over the age of 18 years and/or be the homeowner.** 

DEPOSIT: A deposit of 25% of the full price must be paid at time of order for the bigger units (this is already precalculated on our website). You will receive all rental items clean and ready for use. All equipment is to be picked up on time and checked for damages upon pick-up. Unit must be in satisfactory condition upon pick-up. Additional charges will be assessed for cleaning of equipment returned dirty. Any damages incurred to the unit/games while in your possession is your responsibility, and will result in all costs to repair or replace damaged equipment/games. Commercial rentals must be prepaid in full 5 working days prior to rental date. If canceled 48 hours prior to date of rental, 100% of money paid will be refunded. If canceled less than 48 hours of rental date 50% of payment will be refunded.

**ELECTRICAL SERVICE:** Lessee must furnish an electrical outlet rated at 115 volts with a SLO-BLO 20-amp fuse or 30-amp fuse capacity, located within 50 feet of each unit. We will provide extension cords as needed. Use only ONE extension cord as provided per motor or motor may burn up due to low voltage as longer extension cords are used. Voltage at motor must be over 110 volts. If it is determined that proper electrical service is not available Jumbo Party Rentals can furnish a generator for an additional rental fee.

**SET-UP:** JPR products must be operated over a smooth, compatible surface such as grass or hard surface. The unit may NOT be operated on incompatible surfaces such as **MUD**, **ROCKS**, **DIRT**, **LANDSCAPING MULCH**, **GRAVEL**, **BRICKS**, **OR ANY JAGGED SURFACE**. We do provide tarp for underneath the inflatables however, it is up to you ensure the party area will meet these requirements to be set up properly. (All equipment is sanitized before and after each use).

**OPERATION:** Adult supervision is required at all times for inflatables and games for minors. Do not assemble, disassemble, operate or play with inflatable while under the influence of **alcohol** or **drugs**. Observe and obey rules posted on unit. Lessee is responsible for all equipment rented from the time of receipt until the time of pick up. If you discover something broken or missing, please notify us at once so we may make note of items in question and prevent loss of deposit or replacement costs of items. Compatible age groups must play on equipment at the same time. Age groups must not be mixed. The **MAXIMUM** number of riders of each age group that should play at one time is:
