1.) **DEPOSIT**- AN ADVANCE **DEPOSIT OF 25%** OF TOTAL PRICE IS REQUIRED TO SECURE THE EQUIPMENT OR SERVICES AGREED UPON (THIS IS ALREADY CALCULATED ON OUR WEBSITE FOR EACH UNIT). THE REMAINING BALANCE IS DUE UPON DELIVERY OF THE SCHEDULED DATE. COMMERCIAL EVENTS MUST PAY IN FULL (5) DAYS PRIOR TO SCHEDULED DATE. **ANY AND ALL DAMAGES INCURRED TO THE UNIT WHILE IN YOUR POSSESSION IS YOUR RESPONSIBILITY, THIS INCLUDES, BUT IS NOT LIMITED TO ANY REPAIR OR REPLACEMENT OF THE UNIT OR THE EQUIPMENT INCLUDED.**

2.) **ELECTRICAL REQUIREMENTS-** JUMBO PARTY RENTALS IS NOT RESPONSIBLE FOR PROVIDING APPROPRIATE ELECTRICAL POWER. THE POWER REQUIREMENTS FOR EACH PIECE OF EQUIPMENT IS ONE 20 AMP CIRCUIT UNLESS OTHERWISE NOTED ABOVE, AND IT IS THE RENTER'S RESPONSIBILITY TO ENSURE THAT THESE ARE MET. ALL ITEMS REQUIRING ELECTRICAL POWER MUST BE POSITIONED **WITHIN 50 FEET** OF THE POWER SOURCE. NO REFUNDS WILL BE CREDITED FOR EQUIPMENT THAT CANNOT OPERATE BECAUSE THE RENTER FAILED TO PROVIDE ADEQUATE POWER.

3.) **SPACE REQUIREMENTS-** JUMBO PARTY RENTALS IS NOT RESPONSIBLE FOR PROVIDING ADEQUATE SPACE FOR EQUIPMENT. IT IS RENTER'S RESPONSIBILITY TO ENSURE THAT THIS IS MET. ALL EQUIPMENT IS REQUIRED TO BE SETUP ON A FLAT AND LEVEL SURFACE FREE FROM DEBRIS, SUCH AS GLASS, SHARP METAL OBJECTS, ROCKS, MULCH, OR BROKEN PAVEMENT. REFUNDS WILL NOT BE CREDITED FOR EQUIPMENT THAT CANNOT OPERATE BECAUSE RENTER FAILED TO PROVIDE ADEQUATE SPACE FOR EQUIPMENT. PLEASE CALL IN ADVANCE TO COORDINATE A GOOD PLAN FOR SPACE.

4.) **CANCELLATION-** IF A RESERVATION LESS THAN 48 HOURS OF SCHEDULED EVENT IS CANCELED 100% OF THE DEPOSIT IS FORFEITED. ALL CHARGES WILL BE CREDITED TO YOUR FUTURE EVENT IF RESCHEDULED WITHIN ONE YEAR OF EVENT DATE.

5.) **WEATHER POLICY-** JUMBO PARTY RENTALS IS NOT RESPONSIBLE FOR ACTS SUCH AS RAIN, SNOW, ICE, OR INCLEMENT WEATHER. IF AN EVENT IS CANCELED DUE TO INCLEMENT WEATHER, JUMBO PARTY RENTALS MUST BE NOTIFIED 48 HOURS

PRIOR TO THE START OF THAT EVENT. FAILURE TO DO SO WILL RESULT IN FORFEITURE OF THE DEPOSIT. IF THE 48-HOUR CANCELLATION REQUIREMENT IS MET, THE DEPOSIT SHALL BE CREDITED TO A FUTURE EVENT, WITHIN ONE YEAR FROM ORIGINAL EVENT DATE. IF THE EQUIPMENT HAS ARRIVED AT THE EVENT SITE AND THE EVENT IS CANCELED, 50% OF THE REMAINING BALANCE SHALL BE DUE AND PAYABLE. IF THE EQUIPMENT IS SET UP AND THE EVENT IS CANCELED, THE FULL RENTAL CHARGES SHALL BE DUE AND PAYABLE.

6.) **WIND POLICY- JUMBO PARTY RENTALS IS NOT RESPONSIBLE** IN ANY DELAY IN SET UP OPERATIONS OR CLOSING OF GAMES AND EQUIPMENT DUE TO HIGH WINDS. NO REFUNDS OR CREDITS WILL BE GIVEN.

7.) **RELEASE STATEMENT-** LESSEE AGREES TO HOLD HARMLESS JUMBO PARTY RENTALS, ITS EMPLOYEES, AGENTS, AND REPRESENTATIVES FOR ANY INJURIES AND OR PROPERTY DAMAGE SUSTAINED WHILE PARTICIPATING IN ANY OF THE GAMES AND OR ACTIVITIES PROVIDED BY JUMBO PARTY RENTALS.

8.) **PERMITS AND LICENSES-** THE RENTER SHALL ASSUME THE COST OF ANY PERMITS OR LICENSES IF REQUIRED BY LOCAL OR COUNTY ORDINANCES. (COMMERCIAL USE ONLY)

9.) **COMPLETION OF USE- (IF OVERNIGHT)** TURN OFF ALL BLOWERS AND ENSURE UNIT BEGINS TO DEFLATE. NO FURTHER ACTIONS ARE REQUIRED.
